How much capital does battery manufacturing cost?

In the battery cell manufacturing process,three steps require roughly equal shares of capital expenditures: 35 to 45 percent for electrode-manufacturing equipment,25 to 35 percent for cell-assembly-and-handling equipment, and 30 to 35 percent for cell-finishing equipment (Exhibit 2).

How does China benefit from battery production?

China benefitted from its move into mass production of battery-powered consumer electronics from Japan and Korea in the 1990s, and from its investment in the mining and refining the rare earth metalsneeded for battery production. Likewise, it is in the lead in terms of the battery production line equipment manufacturing.
