#### Are solar panels a fire hazard?

PV panels can introduce an obvious ignition source to the roof level, and therefore, increase the risk of fire. Several high-profile fires have occurred in commercial and industrial buildings with rooftop solar PV systems. PV panels installed over a combustible roof system is discouraged as it will almost certainly increase the severity of a loss.

## Will adding solar panels to a roof affect insurance coverage?

Adding solar panels to a roof may impact insurance coverageand liability in case of damage or accidents. It is essential to consult with insurance providers to ensure that your policy adequately covers your PV system and potential liabilities.

## What happens if you lease a roof space?
