

What is the customs system of the Republic of Lithuania?

The Customs System of the Republic of Lithuania comprises the Customs Department under the Ministry of Finance of the Republic of Lithuania, Customs Criminal Service, Customs Training Centre, Customs Laboratory, Customs Information System Centre and three territorial Customs offices (Vilnius, Kaunas, Klaipeda).

What is a type customs warehouse services in Vilnius?

"A" type customs warehouse services in Vilnius. It is permitted to store goods that are produced outside of the EU in the open warehouses without applying import customs taxes and fees and without application of economical prohibitions and restrictions.

When is import VAT required in Lithuania?

The obligation arises when the goods are presented for the customs formalities in Lithuania, and not when they are acquired or brought into Lithuania. Thus, if the import declaration for the release for free circulation of the goods is accepted by the customs authorities in July, the import VAT will already be required to be paid for them.

How to calculate customs duties & other taxes in Lithuania?

In order to explore customs duties and other taxes as well as conditions of their implementation, you should find out a relevant legislation (EC regulation, Excise or VAT Law of the Republic of Lithuania, etc.). In LITAR (by choosing "Duty calculation" reference), the Tax calculation and validation system (TCVS-web) is also available.

What is the role of customs authorities in Lithuania?

The Customs authorities of Lithuania have a pivotal role, in close co-operation with other authorities, allowing them to: - support legitimate trade and strengthen competitiveness - ensure the correct payment of duties and taxes - combat counterfeiting and piracy;

Do I have to pay import taxes in Lithuania?

Yes, you do. You will need to complete the export declaration and to dispatch the goods to the seller via the Lithuanian Post or express parcel carrier. After the dispatch of the goods, you will have to submit to the territorial customs office, operating within the area of your activity, an application for refund of import taxes paid.
